**GENERAL TERMS AND CONDITIONS OF SEALED OFFER FOR SALE OF

1. The tenders should be submitted in sealed covers. Open tenders will be rejected.
2. The vehicles offered for sale on '**AS-IS-WHERE-IS CONDITION BASIS**'. Taxes & duties as applicable at the time of taking delivery by the successful tenderer will be charged extra over the quoted offer.
3. **The Tenderer may inspect the vehicle on any working day from 05/12/2019 to 19/12/2019 between 9.00 A.M. and 1.00 P.M.** by prior appointment to satisfy themselves about the quality and condition of the vehicle offered. No complaint whatsoever will be entertained after the tenders are submitted or before or after the vehicle is lifted. No request for inspection after submission of the tender will be accepted.
4. The offered amount should clearly be indicated in the prescribed Tender Form, **in Figures and in Words**. Any overwriting in rates or any change and/or alteration without attestation is liable to culminate in the outright rejection of the tender. 11. The successful Tenderer should remove the vehicle within 10 days from the date of issue of award letter. In case the vehicle is not lifted within the time specified, Ground rent as decided by the Committee per day will be charged from the Tenderer for a further period of 7 days. The vehicle not so removed will be treated as abandoned vehicle and the EMD and other sums paid for the vehicle will be forfeited without any reference to the tenderer. For such abandoned vehicle, The Principal, Sainik School, Amaravathinagar reserves the right to re-sale.

12. The address given in the Tender form shall be deemed to be the Tenderer address and correspondence sent on that address shall be considered to have been delivered to the Tenderer. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is returned back undelivered.

13. Transfer of rights of the successful Tenderer in any form will not be permitted. Re-sale, re-auction or other transactions will not be permitted in the premises of the School nor can successful Tenderer endorse his claim and rights to any other person/persons.

competent authority permitting him to clear the vehicle. 
