## GENERAL TERMS AND CONDITIONS OF SEALED OFFER FOR SALE OF COLD STORAGE ACCESSORIES

1. The tenders should be submitted in sealed covers. Open tenders will be rejected.

2. The electrical and electronic items offered for sale on 'AS IS – WHERE IS CONDITION BASIS'. Taxes and duties as applicable at the time of taking delivery by the successful tenderer will be charged extra over the quoted offer.

3. The Tenderer may inspect the items on any working day from 05/12/2019 to 19/12/2019 between 0900 hours and 1300 hours by prior appointment to satisfy themselves about the quality and condition of the items offered. No complaint whatsoever will be entertained after the tenders are submitted or before or after the items are lifted. No request for inspection after submission of the tender will be accepted.

4. The offered amount should clearly be indicated in the prescribed Tender Form, **in Figures and in Words.** Any overwriting in rates or any change and/or alteration without attestation is liable to culminate in the outright rejection of the tender. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.

5. The sale will be awarded to the highest tenderer. Tenders should be valid for a period of 60 days from the date of opening of the tenders.

6. Tender has to be enclosed in a double cover, inner cover containing the tender addressed to `THE PRINCIPAL, SAINIK SCHOOL AMARAVATHINAGAR – 642102, UDUMALPET TALUK, TIRUPPUR DISTRICT, TAMILNADU' and the outer cover should be sealed and super-scribed <u>'OFFER FOR COLD STORAGE</u> <u>ACCESSORIES DUE ON 20-12-2019</u>.

9. Sealed Tenders will be opened on the date and time indicated in the Tender Notice by the Committee appointed by The Principal, Sainik School, Amaravathinagar.

The successful Tenderer should pay balance money less the EMD already deposited should be paid immediately along with <u>GST /TCS applicable</u> of the tender value from the date of issue of award letter by Demand Draft. <u>FAILURE OF WHICH</u> <u>SHALL ENTAIL FORFEITURE OF THE EARNEST MONEY DEPOSIT</u> of the Tenderer and the items will be **DISPOSED OFF** as per the decision of The Principal, Sainik School, Amaravathinagar, without reference to successful Tenderers.

11. The successful Tenderer should remove the items within 48 hours from the date of issue of award letter. In case the items are not lifted within the time specified, Ground rent as decided by the Committee per day will be charged from the Tenderer for a further period of 7 days. The items not so removed will be treated as abandoned and the EMD and other sums paid for the items will be forfeited without any reference to the tenderer. For such abandoned items, The Principal, Sainik School, Amaravathinagar reserves the right to re-sale.

12. The address given in the Tender form shall be deemed to be the Tenderer address and correspondence sent on that address shall be considered to have been delivered to the Tenderer. No claim will be entertained for the reason of forfeiture of the sum deposited in case the correspondence is returned back undelivered.

13. Transfer of rights of the successful Tenderer in any form will not be permitted. Re-sale, re-auction or other transactions will not be permitted in the premises of the School nor can successful Tenderer endorse his claim and rights to any other person/persons.
